Executive Summary

We met with local officials, community leaders and residents of Jersey City as part of this application process and found that even though Jersey City supports cannabis businesses, many individuals still hold outdated beliefs about cannabis use and its financial and social impact on municipalities. The lack of education surrounding cannabis and its reported benefits is also seen at the dispensary level where new customers often report feeling overwhelmed and confused when trying to identify the right cannabis product for them. We've deemed this problem the "cannabis community challenge." The solution is for cannabis businesses and their members to actively educate municipalities on the positive social and economic impact that cannabis businesses can have on communities until cannabis establishments are accepted as part of the town's business community. The following consists of a more detailed summary of our Community Engagement Plans for our host municipality, Jersey City.

Positive Impact Plan

- **Education**: The first order of business in creating a positive impact is through education: education on the history of cannabis prohibition, the science and data on cannabis, and current laws and ordinances in Jersey City and the US.
 - Business owners, residents, patrons, and communities with cultural stigmas within Jersey City all deserve to be educated about cannabis as this plant has the ability to create social change and economic growth.
 - Neon Heights will achieve this goal through sponsoring and promoting educational events, working with community organizers, having open lines of communication with the Jersey City Council, and community outreach.
 - We are proud Cannadmix partners and have sponsored two events at Hudson County Community College which included: paneled educational events, expungement clinics, job fairs, live infusing demos and more. These events are so instrumental in getting facetime with the local community to educate them. Panelists include lawyers, advocates, operators, professors and more.
- **Development:** The economic and cultural development of Jersey City is crucial to the mission and success of Neon Heights.
 - Part of development means assisting individuals that were affected by cannabis prohibition -Neon Heights has a working MOU with Cannademix that includes sponsoring expungement clinics.
 - Another part of development is uplifting existing local small-businesses. Neon Heights has held toy drives and fundraisers for PS 27. NH also plans on working with local small-businesses to collaborate on projects like merchandise

- and events.
- Lastly, Neon Heights aims to create a supportive and fulfilling workplace through thoughtful workforce development, retention, benefits, and management, which will create a happy workforce, who, in turn, will make material contributions to Jersey City.
- Diversity and Inclusion: Neon Heights will prioritize contracting Black, Hispanic, veteran, women, social equity, and microbusinesses (cultivation, manufacturing, wholesale license-holders and ancillary products) vendors and ancillary products to promote diversity and inclusion.

Economic Impact Plan

Goals: Neon Heights' Economic Impact Plan will seek to meet the following goals in the first 3 years of operations:

- Promoting sustainable, socially and economically reparative practices in the cannabis industry in New Jersey.
- Creating a discount program that provides discounts on select products to patrons that produce a receipt from an official small-business in Ward C in Jersey City in order to incentivize individuals to shop small and hyper-local.
- Developing a profit sharing model for eligible employees so that they share in Neon Heights' success.
- Collaborating with local vendors to foster economic growth in Jersey City and promote local brand awareness.
