ROLL CALL

Six of eight active commissioners were present; four constitutes quorum. Commissioners Solowsky and Ristorucci were absent.

SUNSHINE ANNOUNCEMENT

Secretary Lawrence confirmed the Sunshine announcement went out Friday, June 16th.

APPROVAL OF PREVIOUS MINUTES

No other comments from commissioners. May minutes were unanimously approved.

APPROVAL OF 2015-2016 ANNUAL REPORT

2015-2016 Environmental Commission Annual Report was unanimously approved.

COMMUNICATIONS TO THE ENVIRONMENTAL COMMISSION

The Environmental Commission received 11 notifications regarding NJ DEP permit requests. These were compiled by the EC secretary and will be included in the meeting notes.

SCHEDULED SPEAKER

The scheduled speakers for DPW's waste and recycling programs were not in attendance.

OLD BUISINESS

Water's Edge Development

- Commissioners Cucco and Verdibello had a meeting the JCMUA and Suez earlier in the day. JCMUA director Jeremy Farrell was there along with 11-15 other people who have some connection with the City's water supply. The meeting went well.
- The JCMUA will be installing a tracking system to monitor future developments on sites near the Boonton Reservoir. The JCMUA is also planning on improving its notification system.
- The idea of a well-monitoring system was discussed. There was also discussion about working with other municipalities and the State DEP to purchase adjacent private property for extended buffer. There is also the potential issue of encroachment of JC land.
- Commissioner Cucco will be following up regarding this issue.

Sustainable Jersey Green Team

- Looking to implement board diversity survey and analysis. Feasible by September.
 Secretary Lawrence will look into feasibility getting points for municipal GHG assessment.
- Anyone who has any ideas for Sustainable Jersey actions or other sustainability ideas and initiatives should let Commissioner Cucco and Secretary Lawrence know. Commissioner Cucco will be scheduling a follow-up meeting shortly.

NEW BUSINESS

JCEC Budget

- Commissioner Cucco is working on EC budget. She would like it finalized by next month's meeting.
- There was general discussion of what should be included in budget and if EC should be producing and/or distributing educational materials.
- Secretary Lawrence mentioned that the Office of Innovation has been producing a lot
 of useful educational materials for the Year of Water campaign. The commissioners
 expressed interest in learning more about what the Office of Innovation is doing and
 the materials it has available. Secretary Lawrence stated that she would invite them to
 present at the next meeting.

Compact of Mayors

• The Municipal Council passed a resolution reconfirming the City's commitment to combatting climate changing and supporting joining of the Compact of Mayors. Commissioner Cucco will be sending a letter of support for the Compact of Mayors to the Mayor.

Environmental education outreach update

• Commissioner Meggett stated that she is interested in promoting environmental education in Jersey City schools. She recently met with Sustainable Jersey City regarding this issue. She is also interested in joining the Green Team and working on education.



• Secretary Lawrence stated that should would connect Commissioner Meggett with Brianna Lawrence of the Office of Innovation regarding the student science fair that was recently held in City Hall.

McNair Academic High School update

- Commissioner Lanez attended the Humanitarian and Global Responsibility Fair at McNair Academy on behalf of the Environmental Commission. He spoke to scores of students and got them to provide their contact information for potential volunteer opportunities.
- Secretary Lawrence mentioned that the City has two Cities of Service VISTAs for public outreach, green infrastructure, and resiliency initiatives. They will be attending the next EC meeting and coming up with volunteer opportunities.

CLOSING REMARKS AND OTHER BUSINESS BY COMMISSIONERS

- Commissioner Verdibello mentioned that he would like to figure out a way to
 incentivize or subsidize homeowners to switch out their lead connection pipes.
 Commissioner Netchert discussed the potential of getting the City to require the
 phase-out of lead pipes by a certain year or requiring Suez to report on all lead pipes
 throughout the City.
- Secretary Lawrence updated the EC on the adoption of the Resiliency, Adaptation, and Green Infrastructure plans as part of the City's Master Plan by the Planning Board on June 13, 2017. In the later summer or early fall she will be giving public presentations to Society Hill/Country Village and Downtown about the Adaptation recommendations and present potential zoning changes.
- Secretary Lawrence also announced the adoption of the Environmental Resource Inventory by the Planning Board on June 13, 2017.
