The undersigned, Taryn Fielder, General Counsel and Secretary of Veris Residential Trust, a Maryland business trust ("VRT"), the general partner of Veris Residential Partners, L.P., a Delaware limited partnership ("VRPLP"), which is the sole member of M-C Harsimus Partners L.L.C., a New Jersey limited liability company ("Harsimus"), which is the sole member of Plaza VIII & IX Associates L.L.C., a New Jersey limited liability company ("Owner"), hereby certifies that, as of the date hereof, (a) Harsimus is the 100% sole member of Owner, (b) VRPLP is the 100% sole member of Harsimus, (c) VRPLP is owned approximately 78% by VRT as the sole general partner and approximately 22% by a unaffiliated entities as limited partners, control of VRPLP is with VRT, (d) VRT is owned approximately 91% by Veris Residential, L.P., a Delaware limited partnership ("VRLP"), approximately 8.5% by Mack-Cali Property Trust, a Maryland business trust ("MCPT") and less than 1% by Mack-Cali Texas Property, L.P., a Texas limited partnership ("Texas"), (e) MCPT is owned 100% by VRLP, (f) Texas is owned 1% by Mack-Cali Sub XVII, Inc., a Delaware corporation ("Sub XVII"), as general partner, and 99% by VRLP, as limited partner, (g) VRLP is owned approximately 91% by Veris Residential, Inc., a Maryland corporation (the "Corporation"), as general partner, and approximately 9% by various individuals of which no individual owns more than 10%, (h) Sub XVII is owned 100% by the Corporation and (i) the Corporation is a publicly traded company and no individual owns more than 10% of the Corporation.


