PLEASE TAKE NOTICE, that in accordance with N.J.S.A 10:4-12, the "Open Public Meetings Act," there will be a Special Virtual Meeting of the Jersey City Planning Board on April 5th, 2022 at 5:30pm to hear the application filed by 244 Clinton Investment, LLC bearing application number P22-002 for amendment of the previously approved site plan by changing the sideyard setbacks to provide 3'1" sideyard setback on both sides for egress purposes, amendment of both units at the proposed 2-family house from 2 to 3 bedrooms, addition of a roof deck for the 2nd floor unit, the increase of the total proposed square footage from 3,272 to 3,343 sf, the addition of green roof trays to the roof deck and the addition of a 2' overhang in the front of the building for the 2nd and 3rd floor, for the purpose of the amendment of a site plan for a 2-family house which was previously approved under Jersey City Planning Board application P20-006 at 246 Clinton Avenue, Block 18302, Lot 51.02 on the Tax Map of Jersey City.
