## **PLANS, COMMENTS:**

- 1. Provide a signed and sealed topographic and boundary survey drawing prepared by a licensed surveyor.
- 2. The following note must appear on the plan:

"All demolition material and debris and all items removed from the property and the public areas adjacent, shall be disposed outside the City limits of Jersey City in accordance with the rules and regulations of the City's Environmental Commission and in accordance with the regulations and laws of the NJDEP."

3. Show parking lot dimensions on the plan.

4. The entire site improvements, including the irrigation system, shall be located entirely within the confines of the proposed property.

- 5. Provide a lighting plan with illumination contours. The area of illumination shall meet the minimum redevelopment plan requirements.
- 6. Drainage system connection requires JCMUA's review and approval.
- 7. Please notify this office in writing at least 72 hours prior to commencement of construction work.
- 8. Jersey City Division of Engineering reserves the right to inspect the site and impose additional improvements to any damaged areas within the City right-of-way. All improvements must comply with the requirements of City of Jersey City, Division of Engineering Construction Guidelines.
- 9. Upon completion of construction, please provide this office with an as-built plan showing all of the new improvements.
