The undersigned, Taryn Fielder, General Counsel of Veris Residential Trust, general partner of Veris Residential Partners, L.P., sole member of Veris Residential NJ Holdings L.L.C. ("NJ Holdings"), the sole member of 335 Washington Realty, L.L.C. (the "Owner"), hereby certifies that, as of the date hereof, (a) the Owner is owned 100% by NJ Holdings, (b) NJ Holdings is owned 100% by Veris Residential Partners, L.P. ("VRPLP"), (c) Veris Residential Trust ("VRT") is the sole general partner of VRPLP and owns 100% of the common units, (d) Veris Residential, L.P. ("VRLP") owns 91.15% of VRT and no other shareholder owns more than 10% of VRT, (e) VRLP is owned approximately 91% by Veris Residential, Inc. (the "Corporation") and approximately 9% by various individuals, of which no individual owns more than 10% and (f) no individual owns more than 10% of the Corporation.


