## **Understanding of Complete Project**

It is my understanding that the purpose of this project is to prepare Civil Engineering plans and documentation for submission to the Jersey City Board Of Adjustments and the JCMUA to meet the requirements for Minor Development as stipulated by the Jersey City Code and the latest revisions to the JCMUA Rules & Regulations for the Operation of Sewer Systems and the NJDEP-BMP for Stormwater Management. The project is not subject to the New Jersey Soil Erosion and Sediment Control Regulations for Land Development.

The following is a description of the proposed services:

#### **Civil Engineering (Site Plans)**

- 1. <u>Site Grading and Drainage Plan</u>. This plan will indicate the grading of the site and the proposed drainage system. Proposed sewer profile and sections will be provided. The items of the Drainage System shall consist of inlets, manholes and pipes under the ground level parking. A stormwater management system and report for the project site will be prepared to size the storm water management basins for the project.
- 2. <u>Sewer connection application</u>. Application to the JCMUA is part of the scope of work, this task entails communication with the JCMUA to assure the storm water system and the sewer and storm drainage connection depicted on the plans are to the satisfaction of the JCMUA and to provide the civil engineering information required in the JCMUA application checklist.

### ITEMS NOT INCLUDED

Items not included in this proposal are topographic and boundary survey, off-site storm runoff detention basins and retaining walls, offsite roadway improvements, traffic impact statement, traffic signal design, water pressure test in the street and water pressure calculations, TV Video of water and sewer mains, utility extension beyond the property's frontage, pump station design, site remediation, and construction support services and stakeout.

All required application and permit fees will be paid directly by the Applicant.

The boundary and topographic survey must include the sewer system under Whiton Street. Please provide sewer pipe type and size between sewer manholes and the manholes RIM elevations and Inverts.
