The Number Spot Inc ("#TheSpot"), as a social equity, microbusiness and diversely owned business candidate, will be the paradigm of corporate social responsibility within the beautiful Jersey City community. As a corporation formed and fully owned by community members, the #TheSpot will develop a plan to hire community members, work rehabilitation opportunities for impacted community members, and to conduct ongoing outreach, and valuable research to combat the negative impact of the flawed 'war on drugs.' #TheSpot will serve the community first as a beacon of hope and, practically, as an Entrepreneur Incubator and Wealth Retention Generator. We will utilize a percentage of its profits to fund real estate development and preservation initiatives that will empower residents and community stakeholders. The second floor of the building will be the "launching pad" for these initiatives, and many more, with dedicated office space and conference space to exchange new ideas and address community concerns collectively with our community partners.

Naimah Terry, the owner-operator of the #TheSpot and proud daughter of Jersey City, recognizes the unique opportunity afforded by a legal cannabis dispensary to support and stabilize a financially fragile community. It is her intent for #TheSpot to provide a strong private capital base inside of Jersey City's Ward F community. Growing up in the community, Naimah was blessed to have a strong family foundation that fostered her confidence and enabled her to become the international model she is today.

Her dream is to usher others along the "runway" of their lives toward success and fulfillment; and the #TheSpot will provide some fuel for their journey through programming designed to have a progressive economy. Naimah loves her community and knows its potential. Her life today is a testimony of the vast possibilities for the MLK corridor and the Ward F community.

Naimah Terry was born and raised in Jersey City, NJ and is the current property owner at 539 Martin Luther King Drive, Jersey City, NJ 07304. Naimah is an International Plus Size Model

representing brands designed for real women with over 10 years experience in every area of the business. Naimah is a community developer investing in businesses, real estate, and nonprofits whose mission is to redevelop cities into sustainable 21st century communities. Naimah has a BA in Planning and Public Policy with Concentrations in Community Development, Real Estate Development, and Africana Studies from Rutgers University. Naimah also has a Certificate of Applied Politics from George Washington University and interned for the Congressional Black Caucus Foundation while working with HUD.

Naimah is a Board Member of the Jersey City Fashion Week and has been a speaker at numerous youth based nonprofit conferences. Naimah was an active youth member of the JC NAACP and started her early career working with youth at the Urban League of Hudson County and as Aide to Former City Council Member Kalimah Ahmad.

Naimah spent most of her childhood living between her Grandparents home on Wegman parkway, where she walked to Sacred Heart Elementary School on Martin Luther King Drive and Bayview Avenue every day and living with her Grandmother Yvonne Hatchett, a prominent Jersey City Trailblazer, Educator, and Activist. It took a village to raise Naimah, like most children growing up on the Hill, whose parents were victim to the drugs that flooded the community; which puts them in a seemingly endless cycle of incarceration, rehab, and back on the streets with no resources and criminal records. Her grandmother Yvonne was granted custody when Naimah was in the second grade and from that day had Naimah involved in every youth program Jersey City had to offer. Naimah was a member of the youth Choir at Monumental Church, a youth member of the JC NAACP, youth programs at the Urban League of Hudson County, voter registration drives, canvasing the streets for local political leaders, Cotillions, YMCA youth programs. In addition to the youth chapters, Naimah attended all of the board meetings her grandmother served on because she was a single grandmother raising a child with no babysitter at times. Yvonne's community involvement became Naimah's afterschool activities by default and is now deeply engrained in her way of life.

The Number Spot has partnered with Jersey City Real Estate Developer and Consultant, Veronica Sutton. Ms. Sutton was born and raised in Jersey City and had an impressive career at the helm of the Urban League of Hudson County's Real Estate Development Corporation which she cofounded. Veronica will be a managing partner for our community economic

empowerment programs.
