This email is to serve as a description of the following revisions that were made to the original schematic version that we had presented to the community and other interested parties in an open invite Zoom meeting. The enumeration below includes revisions to our initial plans based on the original schematics which were submitted to the Planning Staff for review.

- 1. An additional story was added to the original 5 Story Structure, 6 Story now proposed. Please note that by right, R-3 District allows for a maximum of 8 Stories.
- 2. Consequently, 4 additional units were added to the initial 16 units, now totaling 20 units.
- 3. We maintained the original count of Two- 3 Bedroom Apartments, One- 2 Bedroom apartment and One-Studio per floor. However, in our initial submission, we did not offer Affordable Housing Units. We are now offering 2 Affordable Housing Units in our current submission.
- 4. The code requires a 30 foot rear setback from floors other than the ground floor which is used for parking. Our initial schematic provided for a 10 ft rear setback for the 2nd floor to the roof. We have now increased the setback to 20 feet. Please note that we could have provided the 30 feet rear setback if we were not compelled to line up with the existing structure to our left which has a setback of 13'-5" from our front lot line. Note that front yard setback requires only a minimum of 5 feet to a maximum of 10 feet. Note also that we are dedicating approx. 6'-10" of our property for Fayette street widening.
